All projects submitted to the Ffos Y Fran Intermediate Fund must support local community projects with an educational, environmental or leisure emphasis. The project must be based in and benefit the residents of the County Borough of Merthyr Tydfil and meet one or more of the themes within the Merthyr Tydfil Single Integrated Plan:

People in Merthyr Tydfil have the opportunity and aspiration to learn and develop their skills to maximise their potential

People in Merthyr Tydfil benefit from a strong, sustainable and diverse economy

People, who live and work in Merthyr Tydfil are supported to enjoy a healthier and better quality of

People enjoy a vibrant, attractive, safe and sustainable place in which to live, work, play and visit.

An application seeking to pay for salaries only will not meet the criteria and therefore will not be considered.

If your project requires other funding to be implemented which will be coming from another fund, this match

funding must be in place before you apply to the Ffos Y Fran Intermediate Fund. The panel will require

evidence of match funding secured.

Applications must be submitted with any relevant organisational policies such as Health & Safety, Equal

Opportunities and Child Protection (where applicable). Please refer to the checklist at the end of the

application form for further information.
